**SHOW HOURS: SATURDAY, Oct. 30th from 10:00 AM to 5:00 PM;  
SUNDAY, Oct. 31<sup>st</sup> from 10:00 AM to 5:00 PM.**

**SET UP: FRIDAY, Oct. 29th from Noon to 6:00 PM.**

**DEALERS' DINNER: FRIDAY, Oct. 29th at 5:30 PM.**

**The following conditions are included as part of this contract.**

- 1.) **Retail sales only!** Items must be related to materials, equipment, and services associated with lapidary, mineral, fossil, and gemstone hobbies and crafts. Materials and equipment for sale must be correctly labeled. Misrepresentation by a dealer shall subject that dealer to closure without recourse.
- 2.) The dealer can provide signage showing the business name of the dealer.
- 3.) **Minimum rental of one table.**
- 4.) Location of dealer's booth will be at the discretion of the Show's chairman.
- 5.) Lighting for tables and cases is the dealer's responsibility. Booths will have approximately 15 amps of service provided. Dealers must provide their own extension cords.
- 6.) **All tables are to be covered with fire resistant, floor length covers. Staples and nails are not to be used on the tables.** Tape may be used.
- 7.) Each space will be provided with two chairs. Back up tables may be rented at \$10.00 per table. Backup tables are not to be used as sales tables. Dealers may bring their own backup tables at no charge.
- 8.) Security will be provided. Dealers who want to insure themselves against liability claims from the public and others for injury to person or damage to property will do so at their own expense.
- 9.) **Dealers are responsible for collecting 6.5% state/county sales tax.**
- 10.) Dealers understand that they are to remit a deposit of half of the total space rent with this signed contract. The Show's Dealer Chairman will collect any balance Saturday morning, Oct. 30, 2010. Dealers understand that any cancellation of this contract for any reason by the dealer after October 4, 2010 shall waive their right to any refund at the option of the Show Committee. Every effort will be made to re-sell any cancelled space and if successful, a refund will be sent of the monies collected less \$50.00. If for any reason the show is cancelled, dealer waives any claims other than a refund of monies on deposit.

**Please note the following:** Pets are not to be inside the sales area. Load out begins when the show is over. There is no scheduled security for Sunday night.
