

St. Lucie County Rock & Gem Club Annual Show & Sales Contract

Location: Martin County Fairgrounds, 2616 SE Dixie Highway, Stuart, FL 34996

Show dates: Saturday & Sunday, October 29 & 30, 2010, (10:00 AM – 5:00PM daily). Load in – Friday, October 28, 2011 (Noon – 6:00 PM).

Dealers' dinner: Friday, October 28th at 5:30 PM – Dinner provided by the SLCR&G Club. A hospitality booth is provided for vendors and club members throughout the duration of the show.

The following conditions are included as part of this contract.

- (1.) **Retail** sales only. Dealer must collect 6.5% state/county sales tax.
- (2.) Materials must be represented correctly. Misrepresentation may result in closure without recourse.
- (3.) Dealer is encouraged to provide signage showing business name.
- (4.) Location and position of table(s) is at the sole discretion of the Show Chairperson. Each sales area will be provided with two (2) chairs.
- (5.) Dealer is responsible for any table/display lighting, and will provide his/her own grounded electrical cords.
- (6.) All tables are to be covered with floor length, flame resistant covers. (No nails or staples may be used on the tables).
- (7.) Dealer may use their own back-up table or rent one from the club. **No sales from back-up tables.**
- (8.) Security will be provided from Friday noon until last load out Sunday evening. Dealers may secure their own liability insurance.
- (9.) A deposit of at least half the total must accompany this contract. If not accepted, deposit will be refunded.

Cancellation of this contract by the dealer after Oct. 3, 2011 will waive any refund unless the space is sold to another dealer. If so, a refund less \$50.00 will be sent to the dealer. If for any reason the show is canceled, dealers will be notified ASAP, and refunded any monies on deposit.
